
The following prices are for full color advertisements that will be a direct, one-click link to your business's website. The prices reflect upload-ready artwork or images that can be quickly adapted for the *Inkspot's* layout. Advertisements will be displayed on all devices - desktop, tablet, or mobile.

Advertising cycle options are based on the NCHS semester breakdown - August-January; January-May. Summer ad placement is included complimentary for the non-school months of May-August with a year-long ad purchase.

- LARGE LEADERBOARD AD PLACEMENT**
 full color, one click to your website, 728px wide x 90px tall
\$200/semester; \$360/year - your ad will rotate in the ad space at the top edge of the website, above the header (728px x 90px) of the main landing page of the site. It will rotate with no more than two other ads.
- SMALL LEADERBOARD AD PLACEMENT**
 full color, one click to your website, 205px wide x 90px tall
\$150/semester; \$280/year - your ad will rotate in the ad space on the right hand side of the ad space at the top edge of the website, above the header placement (205px by 90px) on the main landing page of the site and will rotate with no more than two other ads.

Ads will not appear on the front or back page of the *Inkspot*. Ads will be placed within the newspaper at random, based on a first-come, first-served basis.



WEB ADVERTISEMENT
