

PUBLICATION OVERVIEW

The *Inkspot* serves as the official student-run and student-produced news publication of Normal Community High School, a four-year secondary school with an enrollment of over 2100 students and 180 staff members.

In its 73rd year as the official news source of Normal Community, the publication aims to represent the diverse interests and perspectives of NCHS students. Writing and reporting with a focus on school and community news, the *Inkspot* aims to cover the stories and issues that concern the high school demographic, emphasizing the NCHS student perspective in our reporting.

Today, the *Inkspot* is primarily a multimedia publication, updated multiple times a week at NCHSinkspot.com. Through the website, the staff offers livestreaming coverage of athletic events, school assemblies, and select concerts and performances.

Additionally, the *Inkspot* produces 5 print newspaper issues a year.

The award-winning publication has an active social media presence on Instagram, Twitter, Facebook, and YouTube at the handle of NCHSinkspot.

ADVERTISING REVENUE

Advertising revenue helps to support the journalism education process at Normal Community High School. Ad revenue is used to cover reoccurring costs such as: attending local and national journalism competitions and conventions; purchasing and maintaining equipment; covering the cost of web-hosting and the printing cost of the newspaper.

Since the Journalism program is self-funded, this money allows students to compete in the IHSA Sectional and State tournaments – where, in 2018, the publication finished 5th in the state and produced the state champions in Advertising, Editorial Cartooning, and Video News Reporting.

CIRCULATION & AUDIENCE REACH

Historically, NCHSinkspot.com averages 8,000 unique viewers and over 35,000 page views.

From August to October 2020, NCHSinkspot.com has experienced 3,331 unique visitors and 10,017 page views.

Inkspot social media accounts directly reach upwards of 2,000 subscribers/followers daily.

The following prices are for full color advertisements that will be a direct, one-click link to your business's website. The prices reflect upload-ready artwork or images that can be quickly adapted for the *Inkspot's* layout. Advertisements will be displayed on all devices - desktop, tablet, or mobile.

Digital advertising locations are sold on a year-long basis, you may swap the advertisement image four times during the contract run.

Included with each ad purchase:

- Advertisement will be displayed during commercial breaks of livestreaming events
- Advertisement will appear 5 times on the *Inkspot's* Twitter and Instagram accounts

STATIC LEADERBOARD AD PLACEMENT

Full color, one click to your website, 728px wide x 90px tall - \$750/year - your static ad will appear at the top of the NCHSinkspot homepage, above the header. It will not rotate with any other ads.

RIGHT PANEL STATIC AD PLACEMENT

Full color, one click to your website, 250px wide x 250px tall \$500/year - your static ad will appear underneath the top stories carousel - to the right of the news section on the main landing page of the site. It will not rotate with other ads.

RIGHT PANEL ROTATING AD PLACEMENT

Full color, one click to your website, 250px wide by 250px tall \$300/year - your rotating ad will appear next to the news story section on the homepage of the website. It will rotate with no more than two other advertisements on the main landing page of the site.

ROTATING LEADERBOARD AD PLACEMENT


Full color, one click to your website, 728px wide x 90px tall - \$500/year - your rotating ad will appear in the middle of the NCHSinkspot homepage, above the multimedia story section. It will rotate with no more than two other advertisements.
